Approval of Minutes: Motion to approve June 20, 2023 minutes made by Tom Kline and seconded by Mary DiBrigida, all in favor, none opposed.

Old Business:

Morris County Historic Preservation Trust (large grant money): Tom Kline-In June, sent note to Karen stating need of spending \$10,000 to restore electricity to building. Told to come to workshop but agenda was too busy so scheduled to go to next meeting. Connolly & Hickey contractually obligated to Morris County to have an historical preservation architect draw up specifications if we have fire damage. Adjuster said would pay for C&H but not for electric. For wire damage yes, but not for rewiring the museum. C&H recommended hiring an electrical engineer for \$10,000 to make a plan to sign off to get electric turned back on. Can apply for the grant due in February, but still need to have guidance re: electrical so still have to hire professional. 2) Operate building without electricity? Electric panel currently being run to security and furnace. 3) The mega test was done-more than half the circuits failed. 4) Will the electrical engineer be able to assess what part was already damaged or due specifically to fire?

Last year it was determined that the building needed to be painted this year (@\$18,000). Charlie said yes, from Open Space Funds, but didn't communicate that to Council.

Tom to write synopsis of situation to give to Council.

Security cameras? John Cannie helping out; need camera, Discussed claim.

Morris County Heritage Commission History Re-Grant Program (small grant money): Laura Olstein-1) Still working on spending 2022 grant money-trying to spend using CAPES report suggestions. 2) Trying to digitize maps for safety reasons in case of catastrophic loss.
